## FIRST AMENDMENT TO DECLARATION OF COVENANTS AND RESTRICTIONS FOR THE PRESERVE II AT FENWICK HALL AND

## PROVISIONS FOR AND BY-LAWS OF THE PRESERVE II AT FENWICK HALL PROPERTY OWNERS ASSOCIATION, INC.

THIS FIRST AMENDMENT TO DECLARATION is made this 21 day of January 2020 by 1776, LLC (a South Carolina limited liability company), hereinafter referred to as the "Declarant."

The Association shall be governed by a Board of Directors, which shall initially consist of five (5) members.

2. The First Amendment to Declaration shall be construed and interpreted in accordance with, and governed by, the laws of the State of South Carolina. Should any provision herein conflict with such applicable law, such conflict shall be severed from this Declaration and shall not affect the validity of any non-conflicting provision of this First Amendment to Declaration.

Except as set forth in this First Amendment to Declaration, the Declaration shall remain in full force and effect.
