WITNESSETH:

WHEREAS, RIVERVIEW CONDOMINIUM ASSOCIATES, LLC ("Developer") pursuant to Paragraph 17 of the Master Deed has the right in its discretion to make certain changes to the Master Deed and By-laws prior to the termination of its right to manage the Association; and

WHEREAS, Developer wishes to supplement Exhibits "A" and "C" to the Master Deed to provide South Carolina registered surveyor certifications with respect to the horizontal and vertical locations of the Buildings and detailed dimensions of the Residences and Common Elements; and

WHEREAS, Developer wishes to clarify that the provisions of Section 13 of the Master Deed do not apply to initial sales of Residences by the Developer and to correct a typographical error in the first line of Section 13 of the Master Deed.

NOW, THEREFORE, in accordance with Section 17 of the Master Deed, it is hereby agreed by the Co-owners that the Master Deed and the By-Laws are amended as follows:

1. Exhibit "A-1" attached hereto supplements Exhibit "A" to the Master Deed and shows the horizontal and vertical location of the Buildings as certified to by Richard D. Lacey, a CHARLESTONNIZASSO_2

registered land surveyor in the State of South Carolina as required by Section 27-31-110 of the State of South Carolina Code of Laws, 1976, as amended (the "Statute").

- 2. Exhibits "C-1-A" through "C-15-A" attached hereto supplement Exhibit "C" to the Master Deed and show the dimensions of the Residences and Common Elements, as certified by an architect registered in South Carolina pursuant to the Statute.
 - 3. Insert the following phrase at the beginning of Section 13 of the Master Deed: "Excluding any initial sale of a Residence by Developer," and strike the designation "(a)" in the first line of Section 13 which is a typographical error.
- 4. Any defined terms not defined herein shall have the same meaning as set forth in the Master Deed.
